Being a subdivision of part of the east half of the north west quarter of Section Twenty three (23) Township Twenty seven (27) North Range three (3) East in Marion County State of Indiana, described as follows: Beginning at the South east corner of said quarter Section running north with east line thereof down hundred (100) feet thence with the line thereof for by one eighth (1/8) of a mile (5280) feet to the metes and bounds of said quarter Section at a point in said quarter Section and thence south with the east line of said quarter Section thence south with the west line of east half of said quarter Section down hundred (100) feet to the South line of said quarter Section thence east with the South line thereof for one eighth (1/8) of a mile (5280) feet to the beginning.

This subdivision consists of four (4) Lots or Blocks with streets with size & number of feet width of streets marked on this Plat distances given in feet & decimals.
