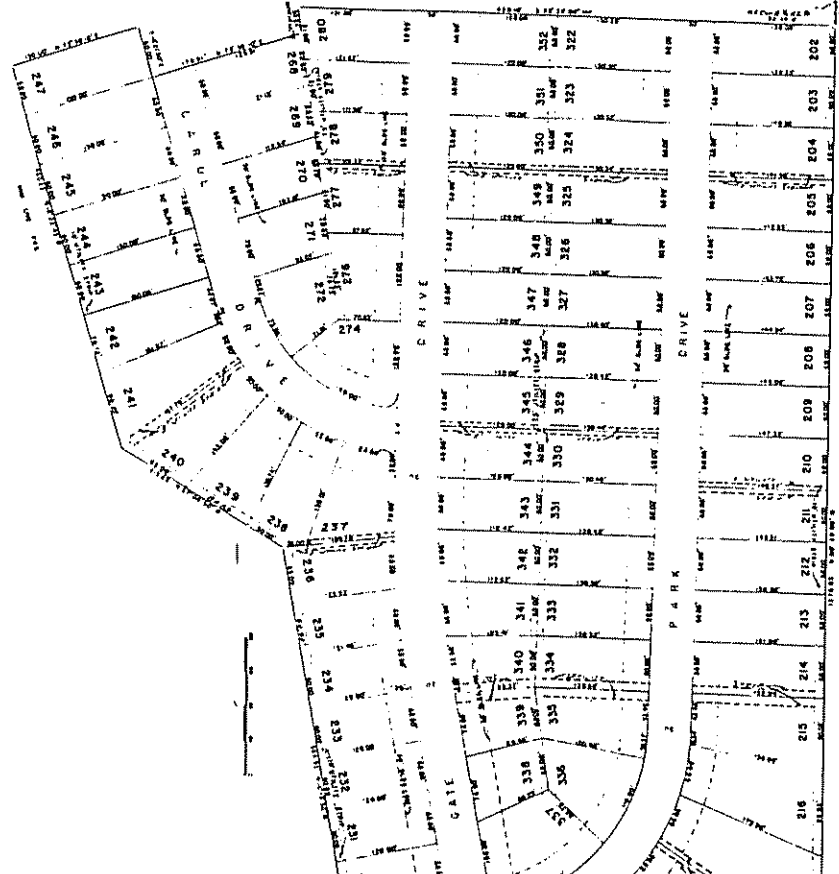

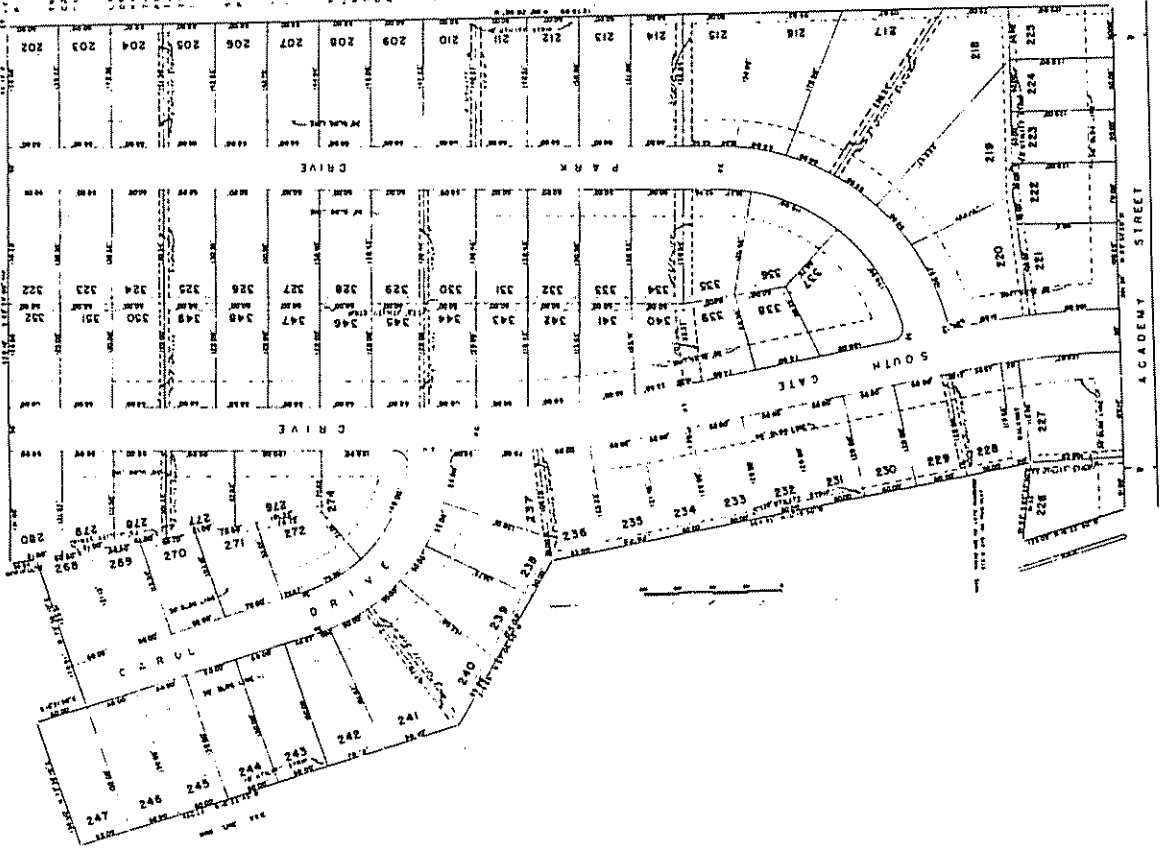

# ADDITION TO NORTHERN PARK ADDITION TO GREENWOOD, INDIANA

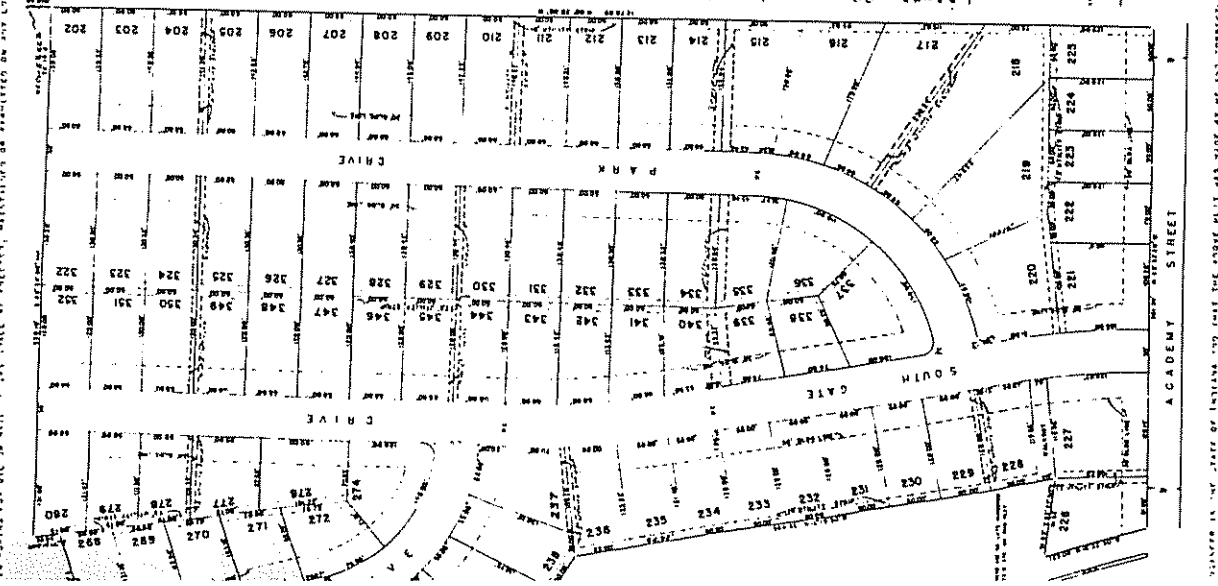
