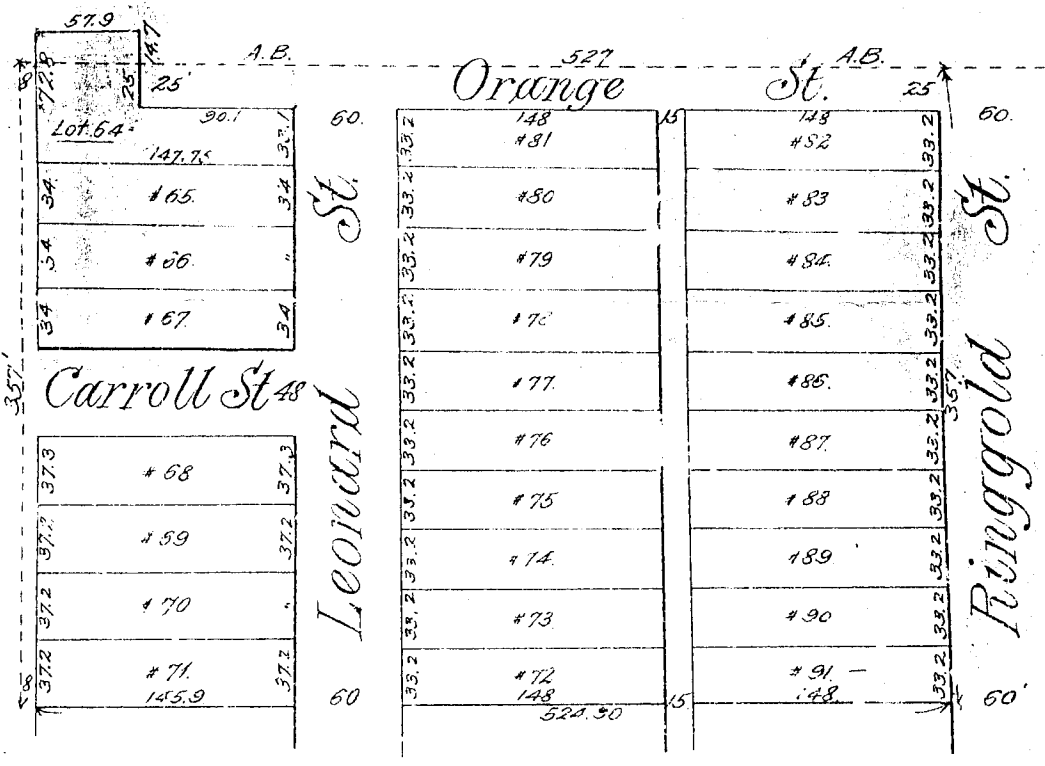

Plat of the Edgewood Addition to the City of Indianapolis, Indiana

The Edgewood Addition to the City of Indianapolis, Indiana, is a quarter section of land, containing four and thirty one hundredths (4.31) Acres. It is bounded on the north by the North Line of the Township Engineer's North Wing & Pine Street, on the east by the East Line of the Township Engineer's North Wing & Pine Street, on the south by the South Line of the Township Engineer's North Wing & Pine Street, and on the west by the West Line of the Township Engineer's North Wing & Pine Street. The Edgewood Addition is bounded on the north by the North Line of the Township Engineer's North Wing & Pine Street, on the east by the East Line of the Township Engineer's North Wing & Pine Street, on the south by the South Line of the Township Engineer's North Wing & Pine Street, and on the west by the West Line of the Township Engineer's North Wing & Pine Street. The Edgewood Addition is bounded on the north by the North Line of the Township Engineer's North Wing & Pine Street, on the east by the East Line of the Township Engineer's North Wing & Pine Street, on the south by the South Line of the Township Engineer's North Wing & Pine Street, and on the west by the West Line of the Township Engineer's North Wing & Pine Street.
