

No 16326. ¹⁸⁷⁸ William J. McLaughlin's Addition to the
Town of Southport.

This annexed plat represents an addition to the town of
Southport Marion County Indiana, laid out by William J. McLaughlin
and shall be known and designated as McLaughlin's Wooded Addition
to the said town.

Said addition embraces the whole of the North East quar-
ter of the North West quarter of section 22 of township 4 north range 10
East 3rd East and contains including all the proposed roads streets
and avenues forty one acres more or less.

Each lot contains about nine and one fourth acres. Each
avenue is forty feet wide and extends the entire length and
width of said subdivision of land.

On the east a strip sixteen feet wide and extending the en-
tire length of said subdivision of land north and south is occu-
pied by a county road, and a strip on the north twenty feet wide
extending the entire width of said land from east to west is occu-
pied by Union Street and also a like strip twenty feet wide on the
west extending the entire length north and south is set off as a
part of Pine Street.

All roads, streets and avenues are hereby dedicated and
set apart for the use and benefit of the public.

The red lines indicate the lines of the lots and the dotted lines in-
dicate the outside limits of the subdivision of land.
